

## **Privacy Notice Development Tool**

#### How to use:

Required information in ORANGE – please complete and turn black prior to submission

The aim of a Privacy Notice to ensure that the participant has all relevant information to allow them to provide valid informed consent regarding the way their data is collected and processed.

The Privacy Notice must:

- Be printed on University of Leicester headed paper
- Contain your Ethics Application Reference number in the footer
- Be version controlled

Each time this Privacy Notice is updated, change the version number and date in the footer to ensure accurate recording and the most up to date documents are always used. The version number should increase by one whole number for each change (i.e., from v1.0 to v2.0 and then v3.0 etc.). If this Privacy Notice is updated due to changes to the way data will be processed, you **MUST** re-consent all participants with the updated Privacy Notice and PIS to ensure that their consent remains informed.

GDPR dictates that anyone collecting personal data MUST provide to individual data subjects a notice informing the individuals about what of their information will be collected, why, how it will be used, how long for and who it will be shared with, by completing and providing this Privacy Notice to your participants you are complying with the law.

## Why do we need your data?

The aim of DLiT is to enliven and connect the multicultural heritage and multilingual memories of 'Diaspora Leicester' in and through translation. You have been invited to participate as you are currently a resident in Leicester and have family backgrounds in languages other than English.

#### University of Leicester's legal basis for collecting this data is:

Processing is necessary for the performance of a task in the public interest such as research.



## What type of data will the University of Leicester use?

This project will collect sayings, poems and songs you have from your family and older generations:

- 1) For "sayings", it is the language of the saying you share, your handwriting, and perhaps your family story associated with it.
- 2) For "poems", it is the handwriting of the older generation of your family, the language used, and the associated story.
- 3) For "songs", it is the the audio-visual data of the older generation of your family, yourself, and the associated story.

You can take part in any or any combination of these forms.

#### Who will the University of Leicester share your data with?

The data collected for this project is for public share, with the permission granted by the participants.

No other research partner institution is involved. The project collaborator is Mr Ambrose Musiyiwa.

## Will the University of Leicester transfer my data outside of the UK?

No.

## What rights do I have regarding my data held by the University of Leicester?

Your normal rights under the Data Protection Act and the General Data Protection Regulation apply. However, we need to manage your records in specific ways for the research project to be reliable. This means that we will not [always] be able to let you see or change the data we hold about you.

You can stop being part of the research project at any time, without giving a reason, but we will keep information about you that we already have and continue to use this for the purposes of the research project as outlined in the Participant Information Sheet.

## Where did the University of Leicester source my data from?

The data will be collected directly from the participants themselves.

#### Are there any consequences of not providing the requested data?

There are no consequences of not providing data for this research. It is purely voluntary.

#### Will there be any automated decision making using my data?

There will be no use of automated decision making in scope of UK Data Protection and Privacy legislation.

## How long will the University of Leicester keep my data?

In line with the law, we will only keep your data for as long as we need to so that we can fulfil our research objectives.

We will keep your personal data, such as your name and email address until we have completed all the actions that require us to hold them, for example sending you a copy of the results of the study if you have requested this, and then the data will be destroyed. This will take no longer than 6 months from when the study ends.
